Health care-associated infection (HCAI) is a major cause of death and disability world wide. HCAI is a major problem for patient safety and its prevention must be a first priority for settings and institutions committed to making health care safer.

The role of hand hygiene to reduce the burden of healthcare-associated infection. Defective hand cleansing (e.g. use of an in sufficient amount of product and / or an insufficient duration of hand hygiene action) leads to poor hand decontamination. Obviously, when HCWs fail to clean their hands during the sequence of care of a single patient and / or between patient's contact, microbial transfer is likely to occur. Contaminated HCW's hands have been associated with endemic HCAI's and also with several HCAI outbreaks.

Hand hygiene is the primary measure proven to be effective in preventing HCAI and the spread of anti microbial resistance. However, it has been shown that HCW's encounter difficulties in complying with hand hygiene indications at different levels.
